## **Our dinner mystery evening**

On February 23 we held our dinner mystery event at the CNIB's location at 1929 Bayview Avenue in Toronto. We played to a full house and our event included dinner, a game show hosted by Kelly MacDonald of Accessible Media Inc and then the mystery. We had the honour of the presence of Louise Gillis, president of the Canadian Council of the Blind.

The dinner consisted of a choice of pizza and a salad or chicken wings and a salad. The game show consisted of 3 contestants being chosen from the audience and they each had to answer a total of five questions and were rewarded with \$5 for every correct answer that they gave. The contestants faired well in their responses.

Categories included Canadian trivia, famous mothers and wives, and answers beginning with the letter Q.

We gave away eight door prizes that included bottles of wine and gift cards as well as a gift package from the Body Shop.

Our play was all about 3 suspects who all pleaded guilty to the murder of a lady named Voluptuous Vivienne.

Suspect 1 named Donaldo Trump said that he did it in order to get rid of Vivienne because she had become a huge bother to him.

Suspect 2 named Kathleen Wingate said that she did it because Vivienne had turned her down.
